ORDER

On August 20, 2018, Water Service Corporation of Kentucky (Water Service Kentucky) filed a motion for deviation from the regulatory notice requirement set forth in 807 KAR 5:001, Section 17(1)(b). Water Service Kentucky cited 807 KAR 5:001, Section 22, as a basis for the Commission's authority to grant deviation from the rules of this regulation for "good cause" shown.

Water Service Kentucky explained that Section 17(1)(b) requires online posting of the public notice and hyperlink to the Commission's online case file be made within five days from the date the application is deemed filed. Water Service Kentucky discovered the failure to post the required information upon receiving Commission Staff's Second Request for Information on August 13, 2018, and corrected the oversight by the morning of August 14, 2018. Additionally, the record contains evidence that Water Service Kentucky has otherwise complied with all other notice requirements, having provided notice by several other forms of media, including newspaper and announcing at public meetings.

Having reviewed Water Service Kentucky's motion and description of its actions to correct the oversight, the Commission finds there is good cause to grant Water Service Kentucky's motion for deviation.

IT IS THEREFORE ORDERED that:

- Water Service Kentucky's Motion for Deviation from 807 KAR 5:011,
 Section 17(1)(b), is granted.
- Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
