Pursuant to 807 KAR 5:056, Section 1(11), IT IS HEREBY ORDERED that:

1. A public hearing shall be held on October 9, 2018, at 9:00 a.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of: Big Sandy Rural Electric Cooperative Corporation, Blue Grass Energy Cooperative Corporation, Clark Energy Cooperative, Inc., Cumberland Valley Electric, Inc., Farmers Rural Electric Cooperative Corporation, Fleming-Mason Energy Cooperative, Inc., Grayson Rural Electric Cooperative Corporation, Inter-County Energy Cooperative Corporation, Jackson Energy Cooperative Corporation, Licking Valley Rural Electric Cooperative Corporation, Nolin Rural Electric Cooperative Corporation, Owen Electric Cooperative, Inc., Salt River Electric Cooperative Corporation, Shelby Energy Cooperative, Inc., South Kentucky Rural Electric Cooperative Corporation, and Taylor County Rural Electric Cooperative Corporation (collectively Cooperatives or individually Cooperative) from November 1, 2017, through April 30, 2018. If no interested party files written notice of its intent to attend this hearing with the Commission by October 2, 2018, this public hearing shall be

cancelled and the matter shall be considered submitted for decision based on the evidence in the record.

- Each Cooperative shall individually file with the Commission, no later than
 days from the date of entry of this Order, an affidavit attesting to its compliance or noncompliance with the requirements of 807 KAR 5:056.
- 3. All documents that the Cooperatives filed with the Commission pursuant to 807 KAR 5:056, Section 1(7) and 1(9), during the period under review are incorporated by reference into the record of this proceeding.
- 4. Each Cooperative shall publish the following notice, using the template below, no less than 7 days or more than 21 days prior to the public hearing, in a newspaper of general circulation in its service areas or in a trade publication or newsletter going to all customers. Each Cooperative shall also file an Affidavit of Publication of Hearing Notice with the Commission no later than October 8, 2018.

A public hearing will be held on October 9, 2018, at 9:00 a.m. Eastern Daylight Time, at the offices of the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky, to examine the application of the Fuel Adjustment Clause of [UTILITY NAME] for the period November 1, 2017, through April 30, 2018, Individuals interested in attending this hearing shall notify the Public Service Commission in writing of their intent to attend no later than October 2, 2018. If no notices of intent to attend are received by that date, this hearing will be cancelled and the matter shall be considered submitted for decision based on the evidence in the record. Written notice of intent to attend this hearing should be sent to: Executive Director, Kentucky Public Service Commission, P.O. Box 615, Frankfort, Kentucky, 40602, and should specify the Cooperative to which the comments relate.

- 5. The official record of the proceeding shall be by digital video recording only.
- 6. Any request for intervention must be filed by August 24, 2018.

7. A person who submits a motion to intervene after August 24, 2018, and
upon a showing of good cause is granted full intervention, shall accept and abide by the
existing procedural schedule.
