## ORDER

On August 17, 2018, South Anderson Water District (South Anderson District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- South Anderson District purchases water from the Frankfort Electric and Water Plant Board (Frankfort) and the city of Lawrenceburg (Lawrenceburg).
- 2. Frankfort notified South Anderson District that the Kentucky River Authority withdrawal fee would increase from \$0.2000 per 1,000 gallons to \$0.2900 per 1,000 gallons effective July 26, 2018.<sup>2</sup> Lawrenceburg notified South Anderson District that the Kentucky River Authority withdrawal fee would increase from \$0.1900 per 1,000 gallons to \$0.3410 per 1,000 gallons effective September 1, 2018.<sup>3</sup> South Anderson District

proposes to increase the water rates to its customers effective September 1, 2018, to reflect the increased cost of purchased water from Frankfort and Lawrenceburg.

- South Anderson District proposed a purchased water adjustment factor of \$0.1100 per 1,000 gallons for residential customers and \$0.1030 per 1,000 gallons for wholesale customers in its application.
- 4. During the 12-month period that ended May 31, 2018, South Anderson District purchased 114,689,500 gallons of water from Frankfort and purchased 82,447,000 gallons of water from Lawrenceburg. During the same period, South Anderson District sold 191,500,832 gallons of water. The increase in the cost of purchased water is \$22,771.56, resulting in a purchased water adjustment factor of \$0.1200 per 1,000 gallons for residential customers and \$0.1189 per 1,000 gallons for wholesale customers. South Anderson District had a calculation error in their application that affected the total increase in the cost of water. This calculation error does affect the increase to the residential customer and the increase to the wholesale customer.
- 5. The purchased water adjustment factor of \$0.1200 per 1,000 gallons for the residential customers and the \$0.1189 per 1,000 gallons for the wholesale customers, as calculated in Appendix A to this Order, is fair, just, and reasonable, and should be approved.
- 6. South Anderson District's proposed residential rates and wholesale rate should be denied.
- 7. The rates as set forth in Appendix B to this Order, are fair, just, and reasonable, and should be approved for water service rendered by South Anderson District on and after September 1, 2018.

8. South Anderson District provided a Customer Notice with its application; the Commission notes that the notice does not meet the minimum requirements. The Customer Notice provided in the application does not provide the increase in the rates by dollar amounts for each customer classification as required. South Anderson District should correct the Customer Notice prior to publishing the notice and filing it with the Commission.

#### IT IS THEREFORE ORDERED that:

- The purchased water adjustment factor of \$0.1200 per 1,000 gallons for residential customers and the purchased water adjustment factor of \$0.1189 per 1,000 gallons for wholesale customers are approved.
- The residential rates and the wholesale rates proposed by South AndersonDistrict are denied.
- The rates as set forth in Appendix B to this Order are approved for water service rendered by South Anderson District on and after September 1, 2018.
- 4. Within 20 days of the date of entry of this Order, South Anderson District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
- 5. Within 30 days of the date of entry of this Order, South Anderson District shall file with the Commission Proof of Notice pursuant to 807 KAR 5:068, Section 5(3).
- 6. Any document filed, pursuant to ordering paragraph 5 of this Order, shall reference this case number and shall be retained in the post-case correspondence file.
  - This case is closed and removed from the Commission's docket.
