ORDER

On August 27, 2018, Martin Gas, Inc. (Martin), filed its proposed Gas Cost Recovery (GCR) rate application to be effective October 1, 2018. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Martin's application includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Martin's application sets out an Expected Gas Cost (EGC) of \$5.1724 per

Mcf.

3. Martin's application sets out no supplier Refund Adjustment.

4. Martin's application sets out a current quarter Actual Adjustment (AA) of (\$.1212) per Mcf and a total AA of (\$.2957) per Mcf.

5. Martin's application sets out no Balance Adjustment.

 Martin's GCR rate is \$4.8767 per Mcf, which is a decrease of \$.2592 per Mcf from the previous GCR rate of \$5.1359 per Mcf.

7. The rates proposed by Martin and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Martin on and after October 1, 2018.

IT IS THEREFORE ORDERED that:

1. The rates set forth in the Appendix to this Order are approved for service rendered on and after October 1, 2018.

2. Within 20 days of the date of entry of this Order, Martin shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
