### ORDER

On September 28, 2018, Atmos Energy Corporation (Atmos) filed its Gas Cost Adjustment (GCA) to be effective November 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Atmos's application includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
- Atmos's Expected Gas Cost (EGC) for firm sales customers is \$4.4228 per
  Mcf. Atmos's EGC for interruptible sales customers is \$3.1148 per Mcf.
  - 3. Atmos's application sets out no Refund Factor.
  - 4. Atmos's application sets out a Correction Factor (CF) of (\$.2849) per Mcf.
- Atmos's application sets out a Performance-Based Rate Recovery Factor
  (PBRRF) of \$.1852 per Mcf.
- 6. Atmos's GCAs are \$4.3231 per Mcf for firm sales customers and \$3.0151 per Mcf for interruptible sales customers. The impact on firm sales customers is a decrease of \$.3340 per Mcf from the previous GCA of \$4.6571 per Mcf. The impact on interruptible sales customers is a decrease of \$.3338 per Mcf from the previous GCA of \$3.3489 per Mcf.

7. The rates proposed by Atmos and set forth in the Appendix to this Order are fair, just and reasonable, and should be approved for final meter readings by Atmos on and after November 1, 2018.

#### IT IS THEREFORE ORDERED that:

- The rates set forth in the Appendix to this Order are approved for final meter readings on and after November 1, 2018.
- 2. Within 20 days of the date of the entry of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
  - 3. This case is closed and removed from the Commission's docket.
