ORDER

This matter arises on a petition filed on January 18, 2017, by Farmers Rural Electric Cooperative Corporation (Farmers RECC), pursuant to 807 KAR 5:001, Section 13, requesting that designated materials filed with the Commission be afforded confidential protection for an indefinite period.

In support of its petition filed on January 18, 2017, Farmers RECC states that public disclosure of the designated materials contained in its response to Item 10c of the Commissions second request for Information would result in competitive injury by weakening Farmers RECC's competitive position in the marketplace for utility management and a skilled workforce.

Having considered the petition and the materials at issue, the Commission finds that the designated materials described in Farmers RECC's January 18, 2017 petition meet the criteria for confidential treatment and are exempted from public disclosure pursuant to KRS 61.878(1)(c)(1).

IT IS THEREFORE ORDERED that:

 Farmers RECC's January 18, 2017 petition for confidential protection is granted.

- The designated materials shall not be placed in the public record or made available for public inspection for an indefinite period, or until further Orders of this Commission.
- Use of the designated materials in any Commission proceeding shall be in compliance with 807 KAR 5:001, Section 13(9).
- Farmers RECC shall inform the Commission if the designated materials become publicly available or no longer qualify for confidential treatment.
- 5. If a non-party to this proceeding requests to inspect the designated materials granted confidential treatment by this Order and the period during which the materials have been granted confidential treatment has not expired, Farmers RECC shall have 30 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If Farmers RECC is unable to make such demonstration, the requested materials shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.
- The Commission shall not make the designated materials available for inspection for 30 days following an Order finding that the materials no longer qualify for confidential treatment in order to allow Farmers RECC to seek a remedy afforded by law.
