ORDER

The matter is before the Commission upon a motion filed by Kentucky Utilities Company (KU) that requested leave to substitute certain documents that were attached to its response to the Attorney General's Supplemental Data Requests for Information (Attorney General's Supplemental Request), Item 20(b). In support of its motion, KU states that the subject documents contained unredacted bank and routing numbers that 807 KAR 5:001, Section 4(10), requires to be redacted. KU informs that it has uploaded a revised electronic version of the response to the Attorney General's Supplemental Request, Item 20(b), with the redacted pages substituted for the original pages.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that KU has established good cause to permit it to substitute its response to the Attorney General's Supplemental Request, Item 20(b), in order to have financially sensitive information redacted and keep it from being publicly disclosed as required by 807 KAR 5:001, Section 4(10).

IT IS THEREFORE ORDERED that KU's motion to substitute is granted.
