ORDER

On March 15, 2019, SteelRiver Infrastructure Fund North America LP (SRIFNA), and SteelRiver LDC Investments LP (SRLDCI), LDC Parent, LLC (LDC Parent), LDC Funding, LLC (LDC Funding), LDC Holdings, LLC (LDC Holdings), PNG Companies, LLC (PNG), Peoples Gas KY, LLC (Peoples KY), and Delta Natural Gas Company, Inc. (Delta), filed a motion requesting that finding paragraph 3 of the Commission's March 13, 2019 Order be clarified to reflect that SRIFNA, SRLDCI, LDC Parent, and LDC Funding (collectively, Divesting Parties) are not bound by the commitments regarding post-transaction actions of Agua America, Inc. (Agua America), PNG, Peoples KY, or Delta.

The Commission, having considered the evidence of record and being otherwise sufficiently advised, finds that this case should be reopened, Divesting Parties' motion for clarification should be granted, and the March 13, 2019 Order should be amended to

reflect that Aqua America, PNG, and Delta, but not the Divesting Parties, are bound by the commitments made during the course of this proceeding.

IT IS THEREFORE ORDERED that:

- 1. This case is reopened.
- 2. Divesting Parties' motion for clarification is granted.
- 3. Finding paragraph 3 of the March 13, 2019 Order is amended to read:
 - Aqua America, PNG, and Delta have agreed to be bound by respective commitments made during the course of this proceeding.
- 4. All other provisions of the Commission's March 13, 2019 Order that are not in conflict with the terms of this Order shall remain in effect.
 - 5. This case is closed and removed from the Commission's docket.
