ORDER

A hearing was held before the Kentucky Public Service Commission (PSC) on November 22, 2019, at its offices at 211 Sower Boulevard, Frankfort, Kentucky, concerning the allegation that Robert Wells Plumbing d/b/a Well's Plumbing (Robert Wells) violated KRS 367.4911(1)(a) on November 28, 2018, at 200 West Main Street, Clarkson, Kentucky 42726, when he damaged a natural gas pipeline while conducting excavation operations without making a line location request to the One Call Center not less than two nor more than ten full working days prior to commencing work. Robert Wells was served with process, and notified of the hearing date and time, but failed to appear at the hearing to contest the allegations. PSC investigator, Eric Tout testified that he conducted an investigation which established that Robert Wells had not obtained a locate ticket number from 811 and that Robert Wells struck the Leitchfield Gas Company natural gas service line while conducting excavation activities.

FINDINGS OF FACT

The testimony presented at the hearing as well as the exhibits filed in the record stand un rebutted and establish that:

1. Robert Wells was at the time the damage occurred on November 28, 2018, an excavator as defined by KRS 367.4903(4) who caused damage to a natural gas service line by means of excavation as defined by KRS 367.4903(2) and (6). The natural gas service line was an underground facility owned and operated by Leitchfield Gas Company to serve the public. The service line contained natural gas at the time it was damaged by Robert Wells.

2. Robert Wells failed to call the Kentucky Contact Center (One Call Center or Protection Notification Center) to obtain information about the approximate location of the damaged natural gas service line not less than two (2) nor more than ten (10) full working days prior to commencing work as required by KRS 367.4911(1)(a).

3. Robert Wells' excavation work was not emergency work within the scope of KRS 367.4907 or the definition of "Emergency" as defined in KRS 367.4903(7) and no exception to the call requirement is applicable to this case.

4. There are no known mitigating factors which would merit the imposition of a fine less than the maximum provided by law. This violation is Robert Wells' first offense.

CONCLUSIONS OF LAW

1. Robert Wells violated the requirements of KRS 367.4911(1)(a) by failing to provide the operator of an underground facility serving the public with notification of his intended work and work schedule not less than two (2) nor more than ten (10) full working days prior to commencing work.

2. KRS 367.4917(1) provides that an excavator who fails to comply with any provision of KRS 367.4911 shall be guilty of endangering underground facilities and may be subject to a fine of two hundred and fifty dollars (\$250) for the first offense.

3. KRS 367.4917(4) provides that any person who violates any provision of the act that involves damage to a facility containing any flammable, toxic, corrosive, or hazardous material or results in the release of any flammable, toxic, corrosive, or hazardous material shall be subject to a fine not to exceed one thousand dollars (\$1,000) for each offense.

4. Robert Wells is, by reason of his failure to comply with the applicable provisions of Underground Facility Damage Prevention Act as hereinbefore set out, subject to a maximum fine of one thousand two hundred and fifty dollars (\$1,250).

IT IS THEREFORE ORDERED that:

1. Robert Wells is assessed a fine of one thousand two hundred fifty dollars (\$1,250) for violation of KRS 367.4911(1)(a) for failure to provide the Leitchfield Gas Company, the operator of an underground facility serving the public, with notification of its intended work and work schedule not less than two (2) nor more than ten (10) full working days prior to commencing work.

2. Robert Wells shall pay one thousand two hundred fifty dollars (\$1,250) within thirty (30) days of the date of this Order by cashier's check or money order payable to the Kentucky State Treasurer and mailed or delivered to the office of the Kentucky Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky 40602.

THIS IS A FINAL AND APPEALABLE ORDER OF THE PUBLIC SERVICE COMMISSION.

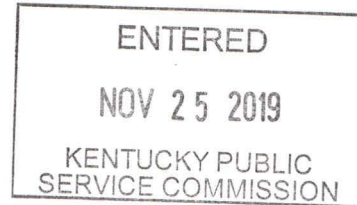
