## ORDER

On September 13, 2019, Airview Utilities, LLC (Airview) moved the Commission to dismiss, without prejudice, the above-styled Notice of Surrender and Abandonment of Utility Property, Case No. 2016-00207.

Based on the motion and being otherwise sufficiently advised, the Commission finds that good cause exists to dismiss this case without prejudice. The Commission finds that its August 14, 2019 Order in Case No. 2019-00104, which approves the transfer of Airview to Bluegrass Water Utility Operating Company, LLC subject to conditions set out in that Order, renders the issue of abandonment in this case moot.<sup>1</sup> The Commission further finds that, in light of our action today, any motions in this proceeding that have yet to be addressed are rendered moot and, therefore, should be denied.

IT IS THEREFORE ORDERED that:

1. Airview's motion to dismiss, without prejudice, Case No. 2016-00207 is granted.
