## ORDER

CMN-RUS, Inc. (CMN) filed a complaint in this matter on May 15, 2018, regarding pole attachment terms and procedures offered by Windstream Kentucky East, LLC (Windstream East). On December 7, 2018, the Commission approved a settlement agreement between CMN and Windstream East and ordered that the case remain open while CMN and Windstream implemented the settlement to address any issues that arise regarding pole attachments as CMN builds out its fiber optic network in Lexington, Kentucky. The parties have filed regular updates pursuant to the December 7, 2018 Order regarding the status of the pole attachments and are expected to notify the Commission when the build out of the network is complete. There are no other parties to this case.

CMN and Windstream East now jointly move the Commission for leave to use the electronic filing procedures set forth in 807 KAR 5:001, Section 8, for all of its future filings due to changes in the Commission's procedures arising from the coronavirus that is

currently affecting the nation. Having reviewed CMN and Windstream East's joint motion and being otherwise sufficiently advised, the Commission finds that the joint motion should be granted and that future filings in this matter should be made and processed pursuant to the electronic filing procedures set forth in 807 KAR 5:001, Section 8.

## IT IS THEREFORE ORDERED that:

- 1. CMN and Windstream East's joint motion for leave to use the electronic filing procedures set forth in 807 KAR 5:001, Section 8, for all of its future filings is hereby granted.
  - 2. This matter is hereby converted to an electronic case.
- 3. Filings in this matter shall be made and processed pursuant to the electronic filing procedures set forth in 807 KAR 5:001, Section 8, from the date this Order is entered forward.
- 4. The Commission's previous Orders in this case are amended and vacated to the extent they conflict with paragraphs 1 through 3 herein.
- 5. All other provisions of the Commission's Orders in this case shall not be affected by this Order.
