ORDER

By Order issued on July 20, 2020, the Commission entered into the record of this case a report summarizing Commission Staff's review (Staff Report) of the 2018 Integrated Resource Plan (IRP) jointly filed by Louisville Gas and Electric Company and Kentucky Utilities Company collectively, LG&E/KU) pursuant to 807 KAR 5:058. That Order also granted the parties ten days to file comments on the Staff Report. All of the parties to this matter submitted timely comments. LG&E/KU agreed to the recommendation that their next IRP be filed on or before October 19, 2021. An informal conference and a formal hearing were also conducted on September 4, 2020, and September 15, 2020, respectively. LG&E/KU filed responses to information requests sought during the informal conference and the formal hearing on September 14, 2020, and September 22, 2020, respectively. Based on the evidence of record and being sufficiently advised, the Commission finds that:

1. The Staff Report's recommendation that the filing date of LG&E/KU's next IRP be October 19, 2021, should be adopted.

2. The Staff Report represents final substantive action in this matter, and this case should now be closed.¹

IT IS THEREFORE ORDERED that:

- 1. KU/LG&E shall file their next IRP no later than October 19, 2021.
- 2. This case is closed and removed from the Commission's docket.
