ORDER

On January 30, 2020, Duke Energy Kentucky, Inc. (Duke Kentucky), filed in accordance with its Gas Cost Adjustment (GCA) Tariff, its GCA report and a proposed GCA rate to be effective March 2, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Duke Kentucky's GCA report includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Duke Kentucky's GCA report sets out an Expected Gas Cost (EGC) of \$2.764 per Mcf, which is a decrease of \$.791 per Mcf from its previous EGC of \$3.555 per Mcf.

 Duke Kentucky's GCA report sets out no current quarter supplier Refund Adjustment (RA).

4. Duke Kentucky's GCA report sets out a current quarter Actual Adjustment (AA) of \$.249 per Mcf. Duke Kentucky's total AA is (\$.565) per Mcf, which is a decrease of \$.209 per Mcf from its previous total AA of (\$.356) per Mcf.

5. Duke Kentucky's GCA report sets out a current quarter Balance Adjustment (BA) of (\$.010) per Mcf. Duke Kentucky's total BA is (\$.019) per Mcf, which is a decrease of \$.001 per Mcf from its previous total BA of (\$.018) per Mcf.

6. Duke Kentucky's GCA is \$2.180 per Mcf, which is a decrease of \$1.001 per Mcf from its previous GCA of \$3.181 per Mcf.

7. Duke Kentucky's application sets out a Gas Cost Adjustment Transition (GCAT) Rider rate of (\$.0584) per 100 cubic feet. This GCAT rate will be applicable to customers who begin receiving Rate FT-L transportation service after the effective date of this Order and who paid gas supply costs through the GCA during the 12-month period before they began receiving FT-L service.

8. The rates as proposed by Duke Kentucky and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Duke Kentucky on and after March 2, 2020.

9. Should Duke Kentucky purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Duke Kentucky and set forth in the Appendix to this Order are approved for final meter readings on and after March 2, 2020.

2. Within 20 days of the date of entry of this Order, Duke Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. Duke Kentucky shall continue to file an electronic version of its GCA report containing the supporting calculations used to compute the GCA in Excel spreadsheet format with all formulas intact and unprotected and with all columns and rows accessible as ordered in Case No. 2018-00143¹.
