ORDER

On January 23, 2020, Louisville Gas and Electric Company and Kentucky Utilities Company (jointly, LG&E/KU) filed a joint motion to schedule a conference in this proceeding. As a basis for the motion, LG&E/KU stated that a conference will assist in the efficient presentation and discussion of issues presented by LG&E/KU's joint application requesting approval of renewable power agreements (RPA). In its application, LG&E/KU requested the Commission issue a final order no later than March 31, 2020.
