## <u>ORDER</u>

On July 2, 2020, Louisville Gas and Electric Company and Kentucky Utilities Company (jointly, LG&E/KU) filed a motion requesting that an informal conference be scheduled and that the existing procedural schedule be held in abeyance. As a basis for the motion, LG&E/KU stated that an informal conference would enable them to make a presentation of information that is technical and complicated, and thus would be more efficient to convey through an informal conference rather than in written data responses. Because the next procedural event is a data request scheduled to be issued on July 9, 2020, and the informal conference could narrow the issues to be addressed on rehearing, LG&E/KU also requested that the existing procedural schedule be suspended until a reasonable time after the informal conference.

Based upon a review of the motion, the Commission finds that an informal conference is likely to be beneficial to the efficient processing of this matter, and therefore LG&E/KU's motion should be granted. The Commission further finds that the existing

procedural schedule should be held in abeyance pending the informal conference as a matter of administrative efficiency.

Based upon the above, an informal conference is scheduled on Tuesday, July 21 2020, at 2:30 p.m. Eastern Daylight Time, for the purpose of discussing After-the-Fact billing and methodology to be applied to LG&E/KU's biennial fuel adjustment clause review. The Commission further finds that the informal conference should be held by videoconference, with Commission Staff contacting participants by electronic mail to provide details for joining the conference.

#### IT IS THEREFORE ORDERED that:

- The informal conference will be held by videoconference on Tuesday, July
   21, 2020, at 2:30 p.m. Eastern Daylight Time.
- 2. The rehearing procedural schedule established by an Order entered on June 18, 2020, is held in abeyance pending further Order by the Commission.
- 3. Commission Staff shall contact participants by electronic mail to provide details for joining the videoconference.
