ORDER

On February 28, 2020, Western Lewis-Rectorville Water and Gas District (Western Lewis-Rectorville District) filed its proposed Gas Cost Recovery (GCR) rate to be effective April 1, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Western Lewis-Rectorville District's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- Western Lewis-Rectorville District's report sets out an Expected Gas Cost
 (EGC) of \$2.8055 per Mcf, which is a decrease of \$.9914 per Mcf from its previous EGC
 of \$3.7969 per Mcf.
- Western Lewis-Rectorville District's report sets out a Refund Adjustment
 (RA) of (\$1.2500) per Mcf.
- 4. Western Lewis-Rectorville District's report sets out a current quarter Actual Adjustment (AA) of \$.2514 per Mcf. Western Lewis-Rectorville District did not use the correct total cost difference for October, November, and December 2019 in the calculation of its current quarter AA. Correcting this produces a current quarter AA of \$.0771 per

Mcf, and a total AA of (\$.6951), which is a decrease of \$.1213 per Mcf from its previous total AA of (\$.5738) per Mcf.

- 5. Western Lewis-Rectorville District's report sets out no Balance Adjustment.
- 6. Western Lewis-Rectorville District's corrected GCR rate is \$.8604 per Mcf, which is a decrease of \$1.1127 per Mcf from the previous GCR rate of \$1.9731 per Mcf.
- 7. The rates as set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Western Lewis-Rectorville District on and after April 1, 2020.
- 8. Should Western Lewis-Rectorville District purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Western Lewis-Rectorville District are denied.
- The rates set forth in the Appendix to this Order are approved for service rendered by Western Lewis-Rectorville District on and after April 1, 2020.
- 3. Within 20 days of the date of entry of this Order, Western Lewis-Rectorville District shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 4. This case is closed and removed from the Commission's docket.
