### <u>ORDER</u>

On May 14, 2020, Beech Grove Water System, Inc. (Beech Grove Water) tendered an application to adjust its rates pursuant to the purchased water adjustment procedure in 807 KAR 5:068.<sup>1</sup> Beech Grove Water responded to one round of discovery.

The Commission notes that Beech Grove Water reported a water loss of 15.5092 percent in its 2019 Annual Report.<sup>2</sup> Beech Grove Water's application provides updated purchase and sales information for a more current period than the 2019 Annual Report. Commission Regulation 807 KAR 5:066(6)(3) states that for ratemaking purposes a utility's unaccounted-for water loss shall not exceed 15 percent of total water produced and purchased, excluding water consumed by a utility in its own operations. Based upon the updated information in the application and the percentage of other water consumed by the utility in its 2019 Annual Report,<sup>3</sup> Beech Grove Water's unaccounted-for water loss is determined to be 19.4488 percent for the updated period.<sup>4</sup> Reduction of Beech Grove

Water's unaccounted-for water loss to 15 percent would result in an approximate \$10,567<sup>5</sup> decrease to purchased water expense. Beech Grove Water is paying approximately \$0.16 per 1,000 gallons sold for expenses associated with unaccounted-for water loss in excess of the allowable 15 percent threshold.<sup>6</sup>

The Commission is placing greater emphasis on monitoring utilities that consistently exceed the 15 percent unaccounted-for water loss threshold and strongly encourages Beech Grove Water to pursue reasonable actions to reduce its unaccounted-for water loss. Failure by Beech Grove Water to make significant progress towards reducing unaccounted-for water loss may cause the Commission to pursue additional action with the utility.

In a review of the Commissions records from 1985 to the present dates, the Commission notes that its records indicate Beech Grove Water has not sought a general base rate adjustment since 2010. The unaccounted-for water loss amounts combined with the lack of insight into Beech Grove Water's financial records supports the Commission's finding that Beech Grove Water should file an application for a traditional adjustment in rates or an alternative rate adjustment within one year of the date of this Order to ensure its revenue is sufficient to support adequate and reliable service.

Having reviewed the record and being sufficiently advised, the Commission finds that:

- 1. Beech Grove Water purchases water from the city of Henderson (Henderson) and West Daviess County Water District (West Daviess District).
- 2. West Daviess District notified Beech Grove Water that its wholesale volumetric water rate would increase from \$3.19 per 1,000 gallons to \$3.84 effective June 1, 2020. Beech Grove Water proposes to increase the water rates to its customers effective June 1, 2020, to reflect the overall increase in cost of purchased water from Henderson.
- 3. The Commission's final Order in West Daviess District Case No. 2020-00150 approved the wholesale rate of \$3.85 per 1,000 gallons to Beech Grove Water.<sup>7</sup>
- 4. Beech Grove reported 36,650,000 gallons in the Other Sales category of its 2019 Annual Report.<sup>8</sup> The Annual Report form directs utilities to provide an explanation for sales reported in this category. Beech Grove Water should in the future fully fill out the Annual Report form to avoid any confusion.
- 5. Beech Grove Water proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons in its application.
- 6. During the 12 months ended April 30, 2019, Beech Grove Water purchased 81,653,447 gallons of water from Henderson and 3,435,900 gallons of water from West Daviess District. During the same period, Beech Grove Water sold 68,231,920 gallons

of water. The increase in the cost of purchased water is \$2,267.69, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.

- 7. The purchased water adjustment factor of \$0.04 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
  - 8. Beech Grove Water's proposed rates should be approved.
- 9. The rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered by Beech Grove Water on and after June 1, 2020.
- 10. Beech Grove Water is charging less per 1,000 gallons at its Bulk Loading Station than Beech Grove Water is paying per 1,000 gallons when purchasing water from its wholesale suppliers.

#### IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.04 per 1,000 gallons is approved.
  - 2. The rates proposed by Beech Grove Water are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Beech Grove Water on and after June 1, 2020.
- 4. Within 20 days of the date of entry of this Order, Beech Grove Water shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
- 5. Beech Grove Water shall provide an explanation of Other Sales when filing future Annual Reports with the Commission.

6. Within one year of the date of this Order, Beech Grove Water shall file an application for a traditional adjustment in rates or an alternative rate adjustment to ensure its revenue is sufficient to support adequate and reliable service.

7. Within 30 days of this Order, Beech Grove Water shall file with the Commission, using the Commission's electronic Tariff Filing System, a nonrecurring charge application adjusting its Bulk Loading Station rate to ensure it is recovering sufficient revenues to cover the expenses incurred to provide the service.

8. This case is closed and removed from the Commission's docket.
