ORDER

On September 11, 2020, the Commission issued an Order granting Water Service Corporation of Kentucky's (Water Service Kentucky's) Motion for Leave to File After Deadline (September 11, 2020 Order). The last sentence of the first paragraph on page 2 of the September 11, 2020 Order reads, "Granting this motion shall not change the procedural schedule amended by the August 28, 2020 Order or Water Service Kentucky's agreement not to implement the proposed rates, subject to refund, earlier than June 15, 2020." The correct date that Water Service Kentucky agreed not to implement rates subject to refund earlier than is December 8, 2020.

Finding that the September 11, 2020 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

1. "June 15, 2020" is stricken from the last sentence of the first paragraph on page 2 of the Order and is replaced with the following language:

December 8, 2020.

2. All other provisions of the Commission's September 11, 2020 Order that are not in conflict with the terms of this Order shall remain in effect.
