## ORDER

The Commission, on its own motion, HEREBY ORDERS that:

- 1. Parties shall present witnesses at the November 17-20, 2020 hearing as follows:

  - d. Kentucky Solar Industry Association (KYSEIA); and
- e. Mountain Association for Community Economic Development,
  Kentuckians for the Commonwealth, and Kentucky Solar Energy Society (Joint Intervenors) witnesses.

- 2. Kentucky Power shall call D. Brett Mattison as its first witness and Alex E. Vaughan as its last witness. Kentucky Power shall file a witness list identifying the order in which its remaining witnesses will be called no later than Thursday, November 12, 2020, at 5:00 p.m. (Eastern Standard Time).
- 3. Kentucky Power witnesses who proffered written testimony and responses to data requests shall be present for the entirety of the hearing.
- 4. The intervening parties shall each file a witness list identifying the order in which their respective witnesses will be called no later than Thursday, November 12, 2020, at 5:00 p.m. (Eastern Standard Time).
- 5. The parties shall provide copies of any documents to be introduced as exhibits at the November 17-20, 2020 hearing to Commission Staff by electronic mail. Commission Staff shall contact the parties with instructions for providing the documents.
