ORDER

On June 5, 2020, West Shelby Water District (West Shelby District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

In a review of the Commissions records from 1985 to the present dates, the Commission notes that its records indicate West Shelby District has not sought a general base rate adjustment since 2009. The lack of insight into West Shelby District's financial records indicates to the Commission that West Shelby District should file an application for a traditional adjustment in rates or an alternative rate adjustment within one year of the date of this Order to ensure its revenue is sufficient to support adequate and reliable service.

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

- West Shelby District purchases water from the Louisville Water Company (Louisville Water) and Shelbyville Municipal Water System (Shelbyville).
- 2. Louisville Water notified West Shelby that its monthly service charge would increase from \$1,364.88 per month to \$1,412.66 per month, and its volumetric wholesale

rate would increase from \$2.36 per 1,000 gallons to \$2.41 per 1,000 gallons effective July 1, 2020. West Shelby District proposes to increase the water rates to its customers effective July 1, 2020, to reflect the increased cost of purchased water from Louisville and Shelbyville.

- 3. West Shelby District proposed a purchased water adjustment factor of \$0.05 per 1,000 gallons in its application.
- 4. During the 12 months ended April 30, 2020, West Shelby District purchased 227,772,000 gallons of water from Louisville and 78,657,090 gallons of water from Shelbyville. During the same period, West Shelby District sold 283,627,300 gallons of water. The increase in the cost of purchased water is \$11,961.96, resulting in a purchased water adjustment factor of \$0.05 per 1,000 gallons.
- 5. In its application, West Shelby District incorrectly calculated the increase in the cost of purchased water.
- 6. The purchased water adjustment factor of \$0.05 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
 - 7. West Shelby District's proposed rates are approved.
- 8. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by West Shelby District on and after July 15, 2020.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.05 per 1,000 gallons is approved.

- 2. The rates proposed by West Shelby District are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by West Shelby District on and after July 15, 2020.
- 4. Within 20 days of the date of entry of this Order, West Shelby District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
- 5. Within one year of the date of this Order, West Shelby District shall file an application for a traditional adjustment in rates or an alternative rate adjustment to ensure its revenue is sufficient to support adequate and reliable service.
 - 6. This case is closed and removed from the Commission's docket.
