ORDER

On July 28, 2020, Columbia Gas of Kentucky, Inc. (Columbia Kentucky) filed its proposed Gas Cost Adjustment (GCA) report to be effective August 27, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Columbia Kentucky's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Columbia Kentucky's report sets out an Expected Gas Cost (EGC) of \$3.2194 per Mcf, which is an increase of \$.0259 per Mcf from its previous EGC of \$3.1935 per Mcf.
3. Columbia Kentucky's report sets out a rate for Banking and Balancing Service of \$.0216 per Mcf.
4. Columbia Kentucky's report sets out no supplier Refund Adjustment (RA), which is no change from its previous total RA.
5. Columbia Kentucky's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$.2354) per Mcf. Columbia Kentucky's total ACA is (\$.4743) per

Mcf, which is an increase of \$.0330 per Mcf from its previous total ACA of (\$.5073) per Mcf.

6. Columbia Kentucky's report sets out a Balancing Adjustment (BA) of (\$.0352) per Mcf, which is a decrease of \$.1103 per Mcf from its previous BA of \$.0751 per Mcf.

7. Columbia Kentucky's report sets out no Special Agency Service (SAS) refund adjustment, which is no change from its previous SAS refund adjustment.

8. Columbia Kentucky's report sets out a Performance-Based Rate (PBR) Adjustment of \$.2167 per Mcf.

9. Columbia Kentucky's GCA is \$2.9266 per Mcf, which is a decrease of \$.0514 per Mcf from the previous GCA of \$2.9780 per Mcf.

10. The rates as proposed by Columbia Kentucky and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for billing with the final meter readings beginning on August 27, 2020.

11. Should Columbia Kentucky purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

12. As ordered by the Commission in Case No. 2018-00150,<sup>1</sup> Columbia Kentucky's future GCA reports should include an electronic version containing supporting calculations in Excel spreadsheet format with all formulas intact and unprotected, and with all columns and rows accessible.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Columbia Kentucky and set forth in the Appendix to this Order are approved for billing beginning on August 27, 2020.
2. Within 20 days of the date of entry of this Order, Columbia Kentucky shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
3. Columbia Kentucky's future GCA reports shall include the information required in finding paragraph 12.
4. This case is closed and removed from the Commission's docket.
