ORDER

On September 23, 2020, Cumberland Valley Electric, Inc., pursuant to the amended “streamlined procedure” established in Case No. 2018-00407,<sup>1</sup> filed an application seeking a general adjustment in its rates. Under the procedure established in Case No. 2018-00407,<sup>2</sup> the Commission, upon receipt of an application, is to issue an Order that, *inter alia*, grants the Attorney General of the Commonwealth of Kentucky, through the Office of Rate Intervention (Attorney General), intervention in the case and establishes a deadline for the filing of comments in the record regarding whether the application should be processed under the streamlined procedure. The Commission also is to, within ten business days, issue an Order accepting or rejecting the application for processing under the streamlined procedure. In this proceeding, the Commission’s Order accepting or rejecting the application for the streamlined procedure is due on or before October 7, 2020.

The Commission, on October 1, 2020, entered an Order granting the Attorney General intervention and also provided that the Attorney General, within seven days of entry of the Order, was to file with the Commission initial comments on whether or not the Commission should accept the application for filing under the streamlined procedure. The last day for the Attorney General to file comments is October 8, 2020, which is after the deadline by which the Commission is to enter its Order accepting or rejecting the application for treatment under the streamlined procedure. Due to this conflict, the Commission finds that deadline for the Commission to enter the Order accepting or rejecting the application for streamlined treatment should be extended by seven days.

IT IS HEREBY ORDERED that:

1. The deadline for the Commission to enter an Order accepting or rejecting Cumberland Valley Electric, Inc.'s application for the streamlined procedure is extended by seven days.
2. The Commission shall enter an Order accepting or rejecting Cumberland Valley Electric, Inc.'s application for the streamlined procedure no later than October 14, 2020.
