ORDER

On August 21, 2020, Millennium Energy, Inc. (Millennium) filed its proposed Gas Cost Recovery (GCR) rate report to be effective October 1, 2020. Millennium's previous GCR rate was approved in Case No. 2020-00166.<sup>1</sup>

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium's report sets out an Expected Gas Cost (EGC) of \$3.2621 per Mcf, which is an increase of \$.7266 per Mcf from its previous EGC of \$2.5355 per Mcf.
3. Millennium's report sets out no supplier Refund Adjustment.
4. Millennium's report sets out a current quarter Actual Adjustment (AA) of (\$.0870) per Mcf. Millennium's total AA is (\$.5632) per Mcf, which is a decrease of \$.0017 per Mcf from its previous total AA of (\$.5615) per Mcf.
5. Millennium's report sets out a current quarter Balance Adjustment (BA) of (\$.0018) per Mcf. In calculating its total BA, Millennium erroneously included an incorrect

amount of (\$.0440) per Mcf for the Third Previous Quarter BA. The correct Third Previous Quarter BA is (\$.0044) per Mcf as approved in Case No. 2019-00426.<sup>2</sup> Correcting this produces a total BA of \$.0039 per Mcf, which is an increase of \$.0139 per Mcf from its previous total BA of (\$.0100) per Mcf.

6. Millennium's corrected GCR rate is \$2.7028 per Mcf, which is an increase of \$.7388 per Mcf from the previous GCR rate of \$1.9640 per Mcf.

7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after October 1, 2020.

8. Should Millennium purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Millennium are denied.
2. The rates set forth in the Appendix to this Order are approved for service rendered on and after October 1, 2020.
3. Within 20 days of the date of entry of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
4. This case is closed and removed from the Commission's docket.
