<u>ORDER</u>

On August 28, 2020, Burkesville Gas Company, Inc. (Burkesville) filed its Gas Cost Recovery (GCR) rate report for rates with a proposed effective date of September 28, 2020. Burkesville's previous GCR rate was approved in Case No. 2020-00159.¹

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Burkesville's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Burkesville's report sets out an Expected Gas Cost (EGC) of \$8.1068 per Mcf, which is an increase of \$1.1290 per Mcf from the previous EGC of \$6.9778 per Mcf.
 - 3. Burkesville's report sets out no Refund Adjustment.
- 4. Burkesville's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$.0713) per Mcf. This produces a total ACA of \$.7554, which is an increase of \$.0078 per Mcf from the previous total ACA of \$.7476 per Mcf.
- 5. Burkesville's GCR rate is \$8.8622 per Mcf, which is an increase of \$1.1368 per Mcf from the previous GCR rate of \$7.7254 per Mcf.

- 6. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after September 28, 2020.
- 7. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

- The rates proposed by Burkesville and set forth in the Appendix to this
 Order are approved for service rendered on and after September 28, 2020.
- 2. Within 20 days of the date of entry of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - This case is closed and removed from the Commission's docket.
