ORDER

The Commission expects the original documents to be filed with the Commission within 30 days of the lifting of the current state of emergency.

- 1. The motion of DOD/FEA to intervene is granted.
- 2. DOD/FEA shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.
- DOD/FEA shall comply with all provisions of the Commission's regulations, 3. 807 KAR 5:001, Section 8, related to the service and electronic filing of documents.
- 4. DOD/FEA shall adhere to the procedural schedule set forth in the Commission's December 9, 2020 Order and as amended by subsequent Orders.
- 5. Pursuant to 807 KAR 5:001, Section 8(9), within seven days of entry of this Order, DOD/FEA shall file a written statement with the Commission that:
- Certifies that it, or its agent, possesses the facilities to receive a. electronic transmissions; and
- Sets forth the electronic mail address to which all electronic notices b. and messages related to this proceeding should be served.
