ORDER

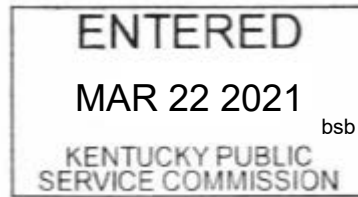
The matter is before the Commission upon motions filed by Kentucky Utilities Company (KU) and Louisville Gas and Electric Company (LG&E) requesting clarification of the Commission's Orders issued on February 18, 2021, in these two instant cases. Alternatively, KU and LG&E (jointly, KU/LG&E) seek reconsideration and modification of the February 18, 2021 Orders. In support of their motions, KU/LG&E point out that the February 18, 2021 Orders granted KU/LG&E's requested relief in part by allowing the companies to file their RTO Membership Analyses at the same time as their triennial Integrated Resource Plan (IRP) filings. However, the February 18, 2021 Order also required KU/LG&E to continue to make annual filings by March 31st of each year, except for years in which an IRP filing must be made, and in those years, the analyses should be filed in conjunction with the IRP. KU/LG&E state that they accept the Commission's requirement of filing the analysis annually but requests that they be allowed to file the analysis by October 31st rather than March 31st. KU/LG&E contend that this will allow

for more up to date information to be incorporated into the analyses because their Load Forecast, Generation Forecast, and Fuel Forecast are typically completed by late summer. KU/LG&E also state that because they will file their IRP in October of this year, requiring the companies to file the RTO Membership Analysis by March of next year would not likely result in any change to the study.

Having reviewed the motions and being otherwise sufficiently advised, the Commission finds that KU and LG&E have established good cause to permit a modification as to when KU/LG&E should file its RTO Membership Analysis on an annual basis. The Commission's February 18, 2021 Order is modified to reflect that KU and LG&E should file their RTO Membership Analyses by October 31st of each year rather than March 31st.

IT IS THEREFORE ORDERED that the motions of KU and LG&E seeking reconsideration and modification of the February 18, 2021 Orders in these two cases are granted.
