ORDER

This matter arises from motions for confidentiality treatment filed by Kentucky Utilities Company (KU) and Louisville Gas and Electric Company (LG&E) (jointly, LG&E/KU), pursuant to 807 KAR 5:001, Section 13, in the respective cases. The motions were filed between November 2018 and March 2019; the Commission has not yet ruled upon the motions. Because this case is closed, the Commission, on its own motion, opens the case to rule upon the motions. To remove the uncertainty regarding the outstanding motions, the Commission will grant all of the 19 outstanding petitions for confidential treatment listed in the Appendix to this Order.

The Commission takes this unorthodox approach due to the passage of time since many of the petitions were filed. The Commission notes that, to its knowledge, no person has sought to review the material for which confidential treatment has been sought in the

various petitions. Thus, granting the petitions will result in no prejudice. A person may

request inspection of the confidential materials pursuant to 807 KAR 5:001,

Section 13(10)(d), at which time the movant that requested confidential protection will

have to justify continued confidential treatment of the material.

The granting of the petitions for confidential treatment by this Order should not be

construed as a finding of the Commission on the merits of each petition. Similarly, the

Commission's granting of confidential treatment should not be cited as precedent in

support of future petitions for confidential treatment.

LG&E/KU should review each confidentiality petition to determine if the information

for which confidential treatment was requested currently warrants confidential treatment.

For example, LG&E/KU should review the petitions to determine if the time for which

confidential protection was requested has elapsed, or if the information had subsequently

become publically available. If LG&E/KU make the determination that the requested

information no longer warrants confidential treatment, LG&E/KU should notify the

Commission in writing of this determination. LG&E/KU's notification will be placed in the

case record and the Commission will make the no-longer confidential information

available for inspection upon request.

IT IS THEREFORE ORDERED that:

1. This case is opened to address certain outstanding petitions for confidential

treatment.

2. The petitions for confidential treatment listed in the Appendix to this Order

are granted.

3. The granting of these petitions shall not be cited as precedent in other

proceedings before the Commission.

4. LG&E/KU shall review the petitions to determine if the material for which

confidential treatment was requested still warrants confidential treatment.

5. LG&E/KU shall inform the Commission in writing in the post-case

correspondence file if LG&E/KU determine that the information contained in a petition that

is granted by this Order no longer warrants confidential treatment.

6. The Commission shall make any materials available for inspection, upon

request, that LG&E/KU determine no longer warrants confidential treatment.

7. This case is closed and removed from the Commission's docket.
