## ORDER

A videoconference hearing in this proceeding on was held on Thursday, January 7, 2021. At the conclusion of the witness testimony, staff counsel requested that Grayson Rural Electric Cooperative Corporation (Grayson RECC) file specific responses to the focused management and operations audit report (Audit Report) prepared by The Liberty Consulting Group (Liberty).

Pursuant to the procedural schedule, Grayson RECC was to file comments in response to the Audit Report on January 6, 2021. The comments that Grayson filed on that date were dated December 10, 2020, and were prepared in response to a preliminary version of the Audit Report. Because the comments were outdated and were inconsistent with hearing testimony, 1 staff counsel requested that Grayson RECC file its comments regarding the Liberty Audit Report concurrently with the action plan filing due on February 26, 2021, and include specific responses to each of the eight recommendations in the Audit report, along with all actions Grayson RECC has taken in regard to the

recommendations, whether it concurs with the deadlines established in the recommendations, and if not, provide a proposed timeline for compliance, along with specific explanation why Grayson RECC cannot meet the proposed timeline.

## IT IS THEREFORE ORDERED that:

- Concurrent with the action plan filing due February 26, 2021, Grayson
   RECC shall file with the Commission Grayson RECC's comments regarding the Liberty
   Audit Report including, but not limited to:
- a. Specific responses to each of the eight recommendations in the Audit report;
- b. All actions Grayson RECC has taken to date in regard to the recommendations;
- c. Whether Grayson RECC concurs with the deadlines established in Liberty's Audit Report recommendations, and if not, provide a proposed timeline for compliance, along with specific explanation why Grayson RECC cannot meet the proposed timeline.
