ORDER

On March 24, 2021, Kentucky Power Company (Kentucky Power) filed a motion to amend the rehearing procedural schedule in this proceeding. Kentucky Power asks that the date for Kentucky Power to either request a hearing or request that the case be submitted for a decision on the record be extended until April 9, 2021. In support of its motion, Kentucky Power states that because the original date by which Kentucky Power was to request a hearing or to submit the case on the record is March 26, 2021, and the date by which Kentucky Power is to respond to Commission Staff's Second Request for Information on Rehearing (Staff's Second Request on Rehearing) is April 2, 2021, Kentucky Power would be required to address the need for a hearing before answering Staff's Second Request on Rehearing.

Having considered the motion and the evidence of record, the Commission finds that this is the last procedural action on the rehearing procedural schedule. Further, the Commission finds that Kentucky Power has shown good cause to amend the rehearing procedural schedule, and that the date for Kentucky Power to request a hearing or that the case be submitted for a decision on the record should be extended to April 9, 2021.

IT IS THEREFORE ORDERED that Kentucky Power shall request a hearing or that this case on rehearing be submitted for a decision on the record no later than April 9, 2021.
