ORDER

This matter arises from an increase proposed by the city of Augusta (Augusta) to its wholesale water rate for Bracken County Water District (Bracken District). On April 30, 2021, the Commission entered an Order scheduling a hearing in this matter on May 21, 2021. On May 5, 2021, Bracken District and Augusta filed a joint motion to continue the hearing indefinitely because they had reached a tentative settlement with respect to the proposed rate increase. On May 13, 2021, Bracken District and Augusta indicated that the settlement had been approved by Bracken District's board and Augusta's city council and filed a joint motion requesting that the Commission cancel the hearing and accept and approve the parties' Settlement Agreement.

Having reviewed the parties' motions and being otherwise sufficiently advised, the Commission grants the parties' joint motion to continue the hearing indefinitely and its motion to cancel the hearing scheduled for May 21, 2021. The Commission will address the parties' joint motion to accept and approve the Settlement Agreement in a subsequent Order.

IT IS THEREFORE ORDERED that:

- 1. The parties' joint motions to continue and cancel the hearing scheduled for May 21, 2021, is granted.
 - 2. The formal hearing scheduled for May 21, 2021, is canceled.
- 3. The parties shall notify third-party witnesses served with a subpoena in this matter, if any, of the cancellation of the hearing.
- 4. The Commission will address the parties' joint motion to accept and approve the Settlement Agreement in a subsequent Order.
