## <u>ORDER</u>

This matter arises from an application for a rate increase and approval of construction filed by Bluegrass Water Utility Operating Company, LLC (Bluegrass Water). Between October 6, 2020, and December 6, 2021, individual residential customers filed 100 comments and letters that were either titled as "Request for Intervention" or otherwise could have been interpreted as a request to intervene in this matter. A list of the customers who made such requests and the dates of their requests is attached as an Appendix to this Order.

The Attorney General is the only person with a statutory right to intervene in a case before the Commission.<sup>1</sup> The Commission's regulations allow other parties to intervene pursuant to 807 KAR 5:001, Section 4(11)(a), which states, in relevant part:

A person who wishes to become a party to a case before the commission may, by timely motion, request leave to intervene.

1. The motion shall include the movant's full name, mailing address, and electronic mail address and shall state his or

her interest in the case and how intervention is likely to present issues or develop facts that will assist the commission in fully considering the matter without unduly complicating or disrupting the proceedings. . . .

Motions to intervene must be served on the other parties to an action pursuant to 807 KAR 5:001, Section 4(8), and proof of service must be filed pursuant to 807 KAR 5:001, Section 6. Motions to intervene are granted based upon the timely filing of a motion to intervene, pursuant to the rules established by the Commission, and a finding that the person seeking intervention has a special interest in the case that is not otherwise adequately represented or is likely to present issues or to develop facts that assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings.<sup>2</sup>

Most of the individual residential customers do not appear to be requesting to participate as parties in the case. While most of the requests are titled as a "Request for Intervention," they do not actually ask to intervene in the body of request. In fact, a number of the "Requests for Intervention" ask only that the Commission "intervene" to prevent Bluegrass Water from implementing the proposed rate, which they argue is unreasonable. Even requests that could be read as actually asking to intervene in the matter do not make any argument to justify their intervention and do not comply with the requirements of 807 KAR 5:001, Section 4(8), Section 4(11)(a), or Section 6. Thus, having reviewed the record and being otherwise sufficiently advised, the individual residential customers failed to establish that they are entitled to intervene 807 KAR 5:001, Section 4(8), Section 4(11).

However, although they have not been granted intervention, the individual residential customers will still have the opportunity to continue to participate in this matter. Specifically, they can review all public documents filed in this case and monitor the proceedings via the Commission's website<sup>3</sup> and may file comments as frequently as they choose, and those comments will be entered into the record of this case pursuant to 807 KAR 5:001, Section 4(11)(e). Further, because the individual residential customers have not been granted intervention, the Commission will treat the filings they have already made as a written public comment to be included in the record of this case. Lastly, the Commission notes that a number of the individuals who filed the "Requests for Intervention" are residents of neighborhoods whose homeowners association has been permitted to intervene on their behalf through counsel.

IT IS THEREFORE ORDERED that the requests to intervene filed by the individual residential customers identified herein are denied.
