COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO KENERGY CORP.

Kenergy Corp., (Kenergy) pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on September 30, 2021. The Commission directs Kenergy to the Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kenergy shall make timely amendment to any prior response if Kenergy obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Kenergy fails or refuses to furnish all or part of the requested information, Kenergy shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Kenergy shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Kenergy's Response to the Commission October 13, 2020 Order² in this proceeding.
 - a. State the number of customers that were placed on Schedule 43 instead of Schedule 46.
 - b. State whether Kenergy has migrated net metering customers who had been placed on Schedule 43 to Schedule 46.
 - c. State whether Kenergy is currently placing net metering customers on Schedule 43 or Schedule 46. Provide this number of customers placed on each schedule since the October 13, 2020 Order.

2. Provide the historical rural load, the historical net metering load, and percentage of net metering as a portion of the rural load, per month, since August 2020.

3. Provide Big Rivers Electric Cooperative Corporation's monthly invoices to Kenergy for Kenergy's rural load since August 2020.

4. a. Provide a list of Kenergy's net metering customers, including those that may be currently receiving service erroneously under Schedule 43 instead of Schedule 46.

b. Provide these customers' individual net metering load, by month, since July 31, 2020.
