SITING BOARD STAFF'S SECOND REQUEST FOR INFORMATION TO GREEN RIVER SOLAR, LLC

Green River Solar, LLC (Green River Solar), pursuant to 807 KAR 5:001, is to file with the Commission an electronic version of the following information. The information requested is due on September 24, 2021. The Siting Board directs Green River Solar to the Kentucky Public Service Commission's July 22, 2021 Order in Case No. 2020-00085¹ regarding filings with the Commission. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the

preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Green River Solar shall make timely amendment to any prior response if Green River Solar obtains information that indicates the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Green River Solar fails or refuses to furnish all or part of the requested information, Green River Solar shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Green River Solar shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- 1. Refer to Siting Board Staff's First Request for Information, Request 24(d), and Site Plan C2.07. Confirm whether there are any gas gathering or distribution lines on parcels 08-00-00-025 or 08-00-00-025.01.
- 2. Refer to Siting Board Staff's First Request for Information, Request 24f.

 Confirm whether adjacent parcel 123-5A is the members-only shooting range on Bishop

Street, also known as Irvington Sportsmen's Club. Also confirm whether the applicant has had any contact with Irvington Sportsmen's Club or its members.

- 3. Submit any leases or easements for collection lines that have been acquired since the application in this matter.
- 4. Provide another version of the "Project Map" (included in the Application as Volume 1, Tab 1, Attachment A) showing a 1,000 and a 2,000-foot project radius boundary similar to the 2 Mile Project Radius Boundary included with the original application.
- 5. Clarify whether any of the land within Array Group A, as designated in Green River Solar's Responses to Staff's First Information Request, is within the city limits of the city of Irvington.
- 6. Confirm whether Green River Solar's arrays have anti-reflective coatings to reduce glare.
- 7. The Traffic and Dust Study states that "Four other site entrances of the project are located on KY 79." (App. Vol. 2 Tab 11 Attach. A Exh 6. Page 3 of 12). The maps in App Vol. 2 Tab 11 Attach A Exh 3 appear to show a total of five site entrances from KY 79, including two on figure C1.07, two on figure C1.09 and one on figure C1.13. Confirm the correct number of anticipated entrances from KY 79.
- 8. Provide a summary of the Meade County Planning and Zoning Department's September 2, 2021, discussion and vote on approval of the Green River Solar project.
