ORDER

On June 11, 2021, the Commission issued an Order that contained an inadvertent error in ordering paragraph 8, approving a seven-year depreciation period for "coal related assets" instead of "Green Station conversion costs," as is discussed in the body of the Order.

Finding that the June 11, 2021 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

- 1. Ordering paragraph 8 is stricken and is replaced with the following language:
 - BREC shall use a seven-year depreciation period for the Green Station conversion costs as set forth in its application
- 2. All other provisions of the Commission's June 11, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.
