ORDER

On April 14, 2021, Nucor Steel Gallatin (Nucor) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) filed a joint motion regarding their intent to jointly sponsor witness testimony in this proceeding. Thus, it appears to the Commission that the Nucor and Attorney General entered into a joint participation agreement.
