ORDER

On July 26, 2021, Nucor Steel Gallatin, LLC (Nucor) filed a motion requesting that the Commission allow Nucor's witness, Stephen J. Baron, to testify by videoconference at the August 3–5, 2021 hearing in this matter. As a basis for the motion, Nucor states that Mr. Baron resides outside of Kentucky and that, for health reasons, is unable to travel to Kentucky to testify due to the possibility of exposure to COVID-19. Nucor further states that Mr. Baron has experience testifying by videoconference during the COVID-19 pandemic. Finally, Nucor states that its remaining witnesses will testify in person.

Based upon the motion and being otherwise sufficiently advised, the Commission finds that Nucor established good cause to grant its motion given Mr. Baron's medical conditions and the potential risk of exposure to COVID-19.

IT IS THEREFORE ORDERED that:

- 1. Nucor's motion for Mr. Baron to testify by videoconference at the August 3–5, 2021 hearing is granted.
- 2. Commission Staff will contact Nucor to provide instructions for Mr. Baron's participation at the hearing by videoconference.
