#### ORDER

On October 12, 2021, Farmers Rural Electric Cooperative Corporation (Farmers RECC), pursuant to KRS 278.400, filed a motion requesting rehearing of the Rate Schedule LPG-1 Large Power Customer Charge (LPG-1) established by the Commission's September 30, 2021 Order.

In its motion, Farmers RECC stated that an incorrect rate of \$4,773.70 was set forth in Appendix B to the September 30, 2021 Order for LPG-1 customer charge. Farmers RECC explained that the LPG-1 customer charge is based upon and therefore should have been identical to the customer charge for large customer rate classes LPE-5, LPB-5, and LPC-5. Farmers RECC further explained that the Appendix B contained the correct customer charge of \$4,659.66 for LPE-5, LPB-5, and LPC-5, and the incorrect customer charge of \$4,773.70 for LPG-1.

Based upon a review of the motion and Appendix B, the Commission finds that Appendix B contained an inadvertent error in the customer charge for LPG-1. The Commission further finds that Appendix B should be amended to replace the incorrect

customer charge of \$4,773.70 for LPG-1 with the correct customer charge of \$4,659.66 for LPG-1.

#### IT IS THEREFORE ORDERED that:

- 1. Farmer RECC's motion for rehearing is granted.
- 2. The LPG-1 customer charge in Appendix B to the September 30, 2021 Order is stricken is replaced with the following language:

## SCHEDULE LPG-1 Large Power

**Customer Charge** 

\$4,659.66

- 3. All other provisions of the Commission's September 30, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.
  - 4. This matter is closed and removed from the Commission's docket.
