<u>O R D E R</u>

On December 15, 2021, Rhudes Creek Solar, LLC (Rhudes Creek Solar) filed a motion for an extension of time to file its response addressing findings and mitigation measures in the Siting Board consultant's report. In accordance with the procedural schedule entered October 4, 2021, Rhudes Creek Solar's response was due December 28, 2021.

As a basis for the motion, Rhudes Creek Solar explained that it needed extra time to respond because Rhudes Creek Solar personnel, who are currently out of the office, need additional time to review and comment on the report. Rhudes Creek Solar requested an extension until January 4, 2022, to file the response addressing the findings and mitigation measures. Rhudes Creek Solar asserted there will still be sufficient time to review the responses before the hearing scheduled for January 13, 2021. Having considered the motion, the Siting Board finds that Rhudes Creek Solar established good cause to grant the extension of time in order to develop a robust record, and therefore the motion is granted.

IT IS THEREFORE ORDERED that:

1. Rhudes Creek Solar's motion is granted.

2. Rhudes Creek Solar shall file its response to the Siting Board consultant's report on or before January 4, 2022.

3. The remainder of the October 4, 2021 procedural schedule shall remain in effect.
