ORDER

On March 26, 2021, Navitas KY NG, LLC (Navitas KY) filed its proposed Gas Cost Recovery (GCR) rate report to be effective May 1, 2021. Navitas KY's previous GCR rate was approved in Case No. 2020-00410.¹

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Navitas KY's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Navitas KY's report sets out an Expected Gas Cost (EGC) of \$8.4406 per Mcf, which is an increase of \$1.2803 per Mcf from its previous EGC of \$7.1603 per Mcf.
 - 3. Navitas KY's report sets out no Refund Adjustment.
- 4. Navitas KY's report sets out a current quarter Actual Cost Adjustment (ACA) of \$.6018 per Mcf. Navitas KY's total ACA is \$1.2554 per Mcf, which is an increase of \$.3520 per Mcf from its previous total ACA of \$.9034 per Mcf.
- 5. Navitas KY's report sets out a current quarter Balancing Adjustment (BA) of (\$.0075) per Mcf. In calculating its total BA, Navitas KY failed to include the third previous

quarter BA of \$.0856 per Mcf that was approved in Case No. 2020-00200.² Correcting this produces a total BA of \$.3289 per Mcf, which is an increase of \$.0069 per Mcf from its previous total BA of \$.3220 per Mcf.

- 6. Navitas KY's corrected GCR rate is \$10.0249 per Mcf, which is an increase of \$1.6392 per Mcf from its previous GCR rate of \$8.3857 per Mcf.
- 7. The rate set forth in the Appendix to this Order is fair, just and reasonable, and should be approved for service rendered by Navitas KY on and after May 1, 2021.

IT IS THEREFORE ORDERED that:

- 1. The rate proposed by Navitas KY is denied.
- 2. The rate set forth in the Appendix to this Order is approved for service rendered by Navitas KY on and after May 1, 2021.
- 2. Within 20 days of the date of entry of this Order, Navitas KY shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
 - This case is closed and removed from the Commission's docket.
