## ORDER

On April 28, 2021, the Commission issued an Order to approve the application requesting approval of the merger agreement filed by West Carroll Water District (West Carroll District) and the city of Carrollton on behalf of Carrollton Utilities (Carrollton Utilities) (collectively, Joint Applicants) pursuant to KRS 278.218, KRS 278.020(6), and KRS 278.020(7). On page three, paragraph two, the Order states that "On April 21, 2021, the Joint Applicants entered into an Asset Purchase Agreement (the Agreement) whereby West Carroll District will merge with and into Carrollton Utilities and Carrollton Utilities will be the surviving water district." The Commission inadvertently referred to the surviving entity as a water district, whereas Carrollton Utilities is a municipally owned utility.<sup>1</sup>

Finding that the April 28, 2021 Order should be amended, the Commission HEREBY ORDERS, *nunc pro tunc*, that:

- 1. The words "water district" are stricken and are replaced with the following language: "municipally owned utility."
- 2. All other provisions of the Commission's April 28, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.
