ORDER

On September 10, 2021, the Attorney General of the Commonwealth of Kentucky, through the Office of Rate Intervention (Attorney General), filed a motion requesting leave to file the corrected testimony of David Dittemore, the Attorney General's revenue requirement witness. In support of the motion, the Attorney General states that following the filing of his testimony, Mr. Dittemore discovered several minor errors in the wording of his testimony. The Attorney General maintains that the changes are limited to wording changes in the body of Mr. Dittemore's testimony to ensure that the wording and figures provided comport with the revenue figures and calculations developed in his schedules and exhibits. Further, the Attorney General states that no changes are proposed to Mr. Dittemore's schedules and exhibits. Columbia Gas of Kentucky has not filed an objection to the Attorney General's motion.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that the motion should be granted.

IT IS THEREFORE ORDERED that the Attorney General is granted leave to file the corrected testimony of David Dittemore.
