#### ORDER

On October 22, 2021, Columbia Gas of Kentucky, Inc. (Columbia Kentucky) and the Attorney General of the Commonwealth of Kentucky, through the Office of Rate Intervention (Attorney General) (collectively, Joint Movants), filed a motion requesting the following:

- That the Attorney General's witnesses, David Dittemore and Richard Baudino be allowed to attend and offer testimony in the November 3, 2021 through November 5, 2021 hearing in this matter via video conferencing;
- That Mr. Baudino be called to testify before noon on November 3, 2021;
- That Columbia Kentucky's witness, John Spanos, be called to testify after 3:45 p.m. on November 3, 2021.

In support of the motion, Joint Movants state that Mr. Dittemore and Mr. Baudino are concerned about the risk of COVID-19 infection associated with in-person testimony. Additionally, Mr. Baudino and Mr. Spanos are scheduled to testify on November 3, 2021, in a hearing in West Virginia. The other party to this proceeding, Kentucky Industrial Utility Customers, has not filed an objection to the motion.

The Commission finds that Joint Movants have presented good cause for the requests made in the motion, and that the motion should be granted. Further, the Commission finds that Commission Staff (Staff) will contact participants by electronic mail to provide details for joining the hearing by video link.

### IT IS THEREFORE ORDERED that:

- 1. Joint Movants' motion is granted.
- 2. Mr. Dittemore and Mr. Baudino shall appear and testify at the November 3, 2021 through November 5, 2021 hearing in this matter via video conferencing.
  - 3. Mr. Baudino shall be called to testify before noon on November 3, 2021.
  - 4. Mr. Spanos will be called to testify after 3:45 p.m. on November 3, 2021.
- 5. Staff shall provide the parties with details for joining the hearing via video link.
