#### ORDER

On July 27, 2021, Delta Natural Gas Company, Inc. (Delta) filed a motion for an extension of time in which to submit its responses to portions of Commission Staff's Second Request for Information and the Attorney General's First Request for Information. Specifically Delta seeks an extension of time up to and including August 13, 2021, in which to file its responses to Items 20, 21, 23, 25, 26, and Items 29 through 37 of Staff's Second Request and Items 9 through 12 of the Attorney General's First Request.

In support of its motion, Delta explains that it learned on July 20, 2021, that one of its witnesses, Mr. Paul Moul, was in a serious bicycle accident that prohibits him from completing responses by July 28, 2021. Further, Delta states that it has engaged Mr. Dylan D'Ascendis, who has adopted Mr. Moul's direct testimony, to respond to the items for which it seeks an extension of time.

The Commission having reviewed the motion and being otherwise sufficiently advised finds good cause to grant Delta's motion and to allow for an extension of time until August 13, 2021, for Delta to file responses to the above-mentioned items contained in Staff's Second Request for Information and the Attorney General's First Request for

Information. The Commission also finds that due to this extension of time, the procedural schedule should be amended. A copy of the amended procedural schedule is attached to this Order as an Appendix.

#### IT IS THEREFORE ORDERED that:

- 1. Delta's motion for an extension of time is granted.
- 2. Delta shall submit its responses to Items 20, 21, 23, 25, 26, and Items 29 through 37 of Staff's Second Request and Items 9 through 12 of the Attorney General's First Request by August 13, 2021.
- Delta shall submit responses to all other Items contained in Staff's Second
   Request for Information and the Attorney General's First Request for Information by July
   28, 2021.
- 4. The procedural schedule issued on June 16, 2021, is stricken and replaced with the procedural schedule attached as an Appendix to this Order.
