## ORDER

The Commission, on its own motion, finds that the procedural schedule established on May 24, 2021, and amended on August 6, 2021, should be further amended to afford Commission Staff (Staff) additional time to prepare and file a Staff Report in this proceeding. By Order entered August 6, 2021, the Commission granted Buffalo Trail Water Association's (Buffalo Trail Water) request for additional time to file response to Commission Staff's Second Request for Information (Staff's Second Request). On August 10, 2021, Buffalo Trail Water filed its responses to Staff's Second Request. On August 11, 2021, Buffalo Trail Water filed updated and supplemental responses to Commission Staff's First Request for Information (Staff's First Request).

Based upon a review of Buffalo Trail Water's multiple responses to Staff's First Request and Staff's Second Request and being otherwise sufficiently informed, the Commission finds that additional time is warranted for Staff to review Buffalo Trail Water's multiple responses in order to ensure a robust and thorough investigation of Buffalo Trail Water's request for a rate adjustment pursuant to 807 KAR 5:076. Therefore, the Commission further finds that the May 24, 2021 procedural schedule, as amended on

August 6, 2021, should be amended to provide until September 14, 2021, for Staff to file a Staff Report in this proceeding.

## IT IS THEREFORE ORDERED that:

- 1. The August 31, 2021 procedural due date to file a Staff Report, in accordance with the May 24, 2021 procedural schedule, as amended on August 6, 2021, is stricken and replaced with a procedural due date of September 14, 2021, to file the Staff Report.
- 2. No later than September 14, 2021, Commission Staff shall file with the Commission and serve upon all parties of record a written report containing its findings regarding Buffalo Trail Water's requested rate adjustment.
- 3. All provisions of the Commission's Order of May 24, 2021, as amended on August 6, 2021, not in conflict with the provisions of this Order shall remain in effect.
