On December 13, 2021, Atmos Energy Corporation (Atmos) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a joint motion to modify the procedural schedule issued as part of the Commission's July 30, 2021 Order. The Commission granted Atmos's motion to continue the hearing in this matter by Order entered December 13, 2021, which stated the Commission would enter an amended procedural schedule by a separate Order.

The Commission finds that an amended procedural schedule should be entered to ensure the continued review of Atmos's application. The Commission grants Atmos and the Attorney General's motion filed on December 13, 2021, to amend the procedural schedule, but denies a portion of the dates proposed. The procedural schedule is attached as an Appendix to this Order.

1. Atmos and the Attorney General's motion filed December 13, 2021, is granted in part and denied in part.
