ORDER

On June 17, 2021, Boone County Water District (Boone District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that Boone District purchases water from the Boone-Florence Water Commission (Boone-Florence). Boone-Florence notified Boone District that its wholesale rate will increase from \$3.59 per 1,000 gallons to \$3.68 per 1,000 gallons, effective July 1, 2021. Boone District proposes to increase the water rates to its customers effective August 1, 2021, to reflect the increased cost of purchased water from Boone-Florence.

Boone District proposed a purchased water adjustment factor of \$0.10 per 1,000 gallons in its application. During the 12 months ended April 30, 2021, Boone District purchased 2,987,563,254 gallons of water from Boone-Florence. During the same period, Boone District sold 2,740,723,793 gallons of water. The increase in the cost of purchased water is \$268,880.70, resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.

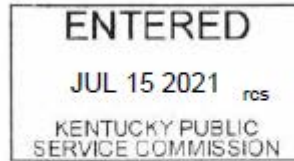

The Commission finds that the purchased water adjustment factor of \$0.10 per 1,000 gallons, as calculated in Appendix A to this Order is fair, just and reasonable and should be approved. The Commission also finds that the rates as set forth in Appendix B to this Order, are fair, just and reasonable and should be approved for water service rendered by Boone District on and after August 1, 2021.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.10 per 1,000 gallons is approved.
2. The rates proposed by Boone District are approved.
3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Boone District on and after August 1, 2021.
4. Within 20 days of the date of entry of this Order, Boone District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
5. This case is closed and removed from the Commission's docket.
