ORDER

On November 11, 2021 McCreary County Water District (McCreary District) filed a motion requesting an additional seven days in which to respond to the Commission Staff's First Request for Information. According to the procedural schedule established by the Commission on October 8, 2021, McCreary District was to file its response to this request for information no later than November 12, 2021.

In support of its motion, McCreary District stated that the requested extension will permit McCreary District to thoroughly respond to the request and avoid errors that might otherwise delay or impede Commission Staff's review of the response. McCreary District also stated that the requested delay may require amending the procedural schedule in this matter, but that McCreary District is not of the opinion that the extension should prevent the Commission Staff from rendering a report or McCreary District from responding to such a report prior to the end of the suspension period.²

Having reviewed the motion and being otherwise sufficiently advised the

Commission regulation 807 KAR 5:001, Section 5(1), to grant McCreary District's motion.

Further, the Commission finds that adjustments to the procedural schedule in this matter

are necessary due to this delay. The schedule to be followed for the remaining procedural

events in this proceeding is attached to this Order as an Appendix.

Because any further extensions of time will hinder the Commission's timely

processing of this case, the Commission advises McCreary District that any further

requests for an extension of time should be accompanied by an agreement that McCreary

District not place the proposed rates into effect until the Commission enters its final Order

in this proceeding.

IT IS THEREFORE ORDERED that:

1. McCreary District's motion for an extension of time is granted.

2. The schedule for the remaining procedural events in this proceeding as set

forth in the Appendix to this Order shall be followed and replaces the procedural schedule

established on October 8, 2021.

3. Nothing contained in this Order shall prevent the Commission from entering

further Orders in this matter.

regulation prohibits a utility from placing proposed rates into effect until the Commission issues a final order or six months from the date of filing its application, whichever occurs first. The applications that are the subject of this proceeding were filed as of September 27, 2021, meaning the rates could go into effect on March 25, 2022.
