ORDER

The Commission, on its own motion, initiates this investigation, pursuant to KRS 278.040, KRS 278.260, and KRS 278.270, to review whether Ledbetter Water District (Ledbetter District) charged its customers unauthorized rates between May 23, 2020, and May 4, 2021, in violation of KRS 278.160 and 807 KAR 5:068.

In Case No. 2021-00158,¹ Ledbetter District filed an application requesting Commission approval of a purchase water agreement (PWA), which the Commission approved by Order entered May 4, 2021. Consistent with the May 4, 2021 Order, Ledbetter District submitted a revised tariff on June 29, 2021, with rates effective as of May 4, 2021. During the processing of that case, Commission Staff (Staff) discovered that Ledbetter District implemented rates as of May 23, 2020, that had not been approved by the Commission. Ledbetter District's manager indicated to Staff that a tariff had been filed containing the proposed rates. However, Staff found no evidence that a tariff had been filed and informed the utility of such.

On May 13, 2021, Ledbetter District submitted a letter² (attached to this Order as an Appendix) in Case No. 2021-00158 admitting that it began charging its customers increased rates as of May 23, 2020, without prior Commission approval. Ledbetter District explained that it filed a PWA with the Commission in May 2020, and that it was rejected for filing due to certain filing deficiencies. Ledbetter District asserted that, due to inexperience of its employees, it put the rates into effect without obtaining prior Commission approval because Ledbetter District did not understand the significance of having the PWA rejected for filing.

The Commission has plenary authority under KRS 278.040 to regulate the rates and services of jurisdictional utilities and to enforce the provisions of KRS Chapter 278.³ It is settled law that a utility may not charge a rate not contained in its tariff and that the tariffed rates must be approved by the Commission.⁴ Further, 807 KAR 5:068, establishes the filing requirements, timeline for the Commission to approve or deny a PWA application, and process to file the revised tariff sheet if the Commission approves the PWA.

Based upon the case record in Case No. 2021-00158, including Ledbetter District's May 13, 2021 letter, the Commission initiates this investigation to determine whether Ledbetter District violated KRS 278.160 and 807 KAR 5:068 between May 23, 2020, and

May 4, 2021, by charging rates to customers that were not approved by the Commission. The Commission, on its own motion, finds the case records of Case No. 2021-00158 should be incorporated by reference into this proceeding.

If the Commission determines that Ledbetter District violated a statute or regulation enforced by the Commission, or an Order entered by the Commission, Ledbetter District may be subject to the assessment of civil penalties in accordance with KRS 278.990.

The Commission directs Ledbetter to the Commission's July 22, 2021 Order in Case No. 2020-00085⁵ regarding filings with the Commission.

IT IS THEREFORE ORDERED that:

- 1. This proceeding is established to investigate whether Ledbetter District charged its customers unauthorized rates in violation of KRS 278.160 and 807 KAR 5:068.
- 2. Within 20 days of the date of entry of this Order, Ledbetter shall submit to the Commission a written response to the allegations contained in this Order.
- 3. The record of Case No. 2021-00158 shall be incorporated by reference into this proceeding.

Ledbetter Water District hereby submits documents in response to a filing deficiency in PWA rate Case No. 2021-00158

Crittenden-Livingston Water District enacted a rate increase from \$ 2.83 cents per thousand to \$3.08 per thousand, increasing its wholesale rates, on March 23 2020. During this time I e-mailed and corresponded with PSC representatives for the purpose ofdoing a Purchased Water Adjustment (PWA), and due to my inexperience and this being my first PWA adjustment I did not file properly. I filled out a tariff form and had the chairman of the water district commission sign it. I sent documents to PSC staff for the purpose of obtaining a PWA. However I have been informed that I did not use the proper filing method. I thought that the filing had been completed. We started charging the rates at this time even though the tariff had not been properly updated from May 23 2019. As referred to in exhibit — A. the rates on proposed tariff sheet I am sending are the rates currently being charged. At the times on this non filed tariff sheet these are the rates being filed.

When I was starting the filing for the 2021 PWA adjustment that is when I realized that I had not properly filed the 2020 PWA. The 2021 PWA from Crittenden Livingston will raise our rates from 3.08 to 3.34 per thousand which we will start being charged MAY 23 of this month, but we will not charge these rates until I have properly filed for and have changed tariff showing that I have your permission to do so.

So in response to the questions in Appendix C:

1. Crittenden Livingston put the rates in effect March 23, 2020.

- 2. Although the documents for a PWA were sent to PSC staff in May 2020, a PWA was not properly filed with the Public Service Commission.
- 3. A. Ledbetter Water District is not currently charging the rates filed in the tariff dated May 23, 2019. The District is charging the rates shown on the attached Tariff sheet: Customer Charge \$7.74 Monthly Rate, then \$6.99 per 1,000 gallons for first 25,000 gallons, \$4.83 per 1,000 gallons all over 25,000 gallons. B. These rates were charged starting May 2020.
- 4. Ledbetter Water District will be filing a PWA in 2021 when we have permission to do so.
