ORDER

On October 1, 2021, North Manchester Water Association, Inc. (North Manchester Water) filed its motion for an extension of time to ask for an extension to the 20 days given to respond in the Commission's September 22, 2021 Order in this matter. North Manchester Water requested an extension until November 26, 2021. As grounds, North Manchester Water stated that materials requested by the Commission were not readily accessible to the utility due to an ongoing audit. The Commission notes that North Manchester Water is required to keep its records at its office pursuant to 807 KAR 5:006, Section 24. Additionally, the only records required for an audit should be electronic copies. North Manchester Water should have access to its records. Finally, the Commission is aware of extreme circumstances affecting the records for North Manchester Water in the past, so if there are circumstances that prevent the full production of requested documents, please indicate that in as much detail as possible in the responses.

The Commission finds good cause to grant an extension in this matter until November 12, 2021. The Commission finds that the requested extension to November 26, 2021, is excessive considering all the materials requested are kept in the normal course of business and an extension to November 12, 2021, will not hamper subsequent information requests that may be needed in preparation for the hearing in this matter on January 11, 2022.

IT IS THEREFORE ORDERED that:

- 1. North Manchester Water's motion filed October 1, 2021, is denied.
- 2. An extension until November 12, 2021, is granted for North Manchester Water; Jerry Rice, in his capacity as general manager; and officers: Steve Davis, Bill Hurd, Carl Gregory Hoskins, Bobby Wolfe, Henry Smith, Ted Woods, Carl David Crawford; individually and in their respective official capacities as officers of North Manchester Water, to submit to the Commission individual written responses to the allegations the Commission's September 22, 2021 Order, including but not limited to any and all written testimony or documentation that would dispute the allegations contained in that Order.
