## <u>ORDER</u>

This matter arises upon a motion to intervene filed by Kentucky Broadband and Cable Association (KBCA) on September 30, 2021. Kenergy Corp. (Kenergy) filed a response on October 5, 2021, and KBCA filed its reply on October 12, 2021. To better assist the Commission in reaching a decision on KBCA's pending motion, the Commission, on its own motion, finds that a virtual hearing should be scheduled.

KBCA's representatives should be prepared to offer testimony in support of their intervention, describing in specific detail KBCA's special interest that is not otherwise adequately represented, or the issues and facts that KBCA will present that will assist the Commission in fully considering this matter.

### IT IS THEREFORE ORDERED that:

- A virtual hearing in this matter shall be held on November 15, 2021 at 9 a.m.
   Eastern Standard Time, in the Richard Raff Hearing Room at the offices of the Public
   Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
- 2. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.
- 3. Commission Staff will contact counsel for Kenergy and KBCA with instructions for participating in the virtual hearing.
- 4. KBCA and Kenergy shall electronically file their respective witness lists with the Commission on or before Wednesday, November 10, 2021.
